Attached is an excel file containing Actual vs Budget to date as well as a summary of checking account activity to date.

<u>Overall</u>, we remain in great shape! Very little has happened since the last meeting. Mainly 1) Lakeside coaches trophies \$99.99 plus engraving on permanent trophies, 2) embroidering fee for 25 Swiss bags \$450, 3) All State scorecard framing payment for 2019 and 2018 \$300, and 4) deposit from honest parents who called me to pay \$42 for their banquet dinner.

<u>Cash in bank - \$10,732.10</u> The only expected expense for the rest of the year is the dinner fee for the December 15 Board meeting. As such, we will have excess cash that we can use to enhance the KGCA All State and keep in reserve for contingencies if sponsors drop us, memberships decline, or some other unexpected issue arises.

Actual vs Budget - the current cash balance \$10,732 exceeds the budget number \$10,331.

<u>Memberships</u> - NO CHANGE SINCE THE LAST MEETING. 144 (140 plus 4 tourneys) received \$7,701.13 (budget \$7,000). Interestingly, three years in a row we have been at 144. The last three years total dollars increased because people join late. 2017 \$7,400, 2018 \$7,600, and 2019 \$7,700 - amounts rounded.

<u>Checking Account Activity Detail</u> - feel free to eyeball all deposits and checks, amount reconciles to agrees with bank balance. Also at the bottom of the sheet the recap agrees with Actual vs Budget spreadsheet above.
